# **Information We Maintain**

The types of personal information we may collect are:

- Contact information (e.g. name, postal address, telephone number and email address);
- Résumé or C.V. information (e.g. employment history, work authorization information, salary history, education history, certifications or trainings);
- Employment information found in your résumé or C.V. (e.g. employer, title, division);
- Other personal information found in content that users provide.

If applying for a position in the United Kingdom, we may also collect additional information if your application is successful:

• Pre-employment information (e.g. citizenship, immigration status, security clearances, criminal history).

### **Legal Ground for Our Use of the Information**

We will use Applicant Information for the above purposes to the extent necessary to pursue our legitimate interest in evaluating potential recruits and in order to take steps at the request of the data subject prior to entering into an employment contract. Failure to provide your personal information may result in the inability for us to process your application.

#### **How We Use the Information We Maintain**

Sperry Marine will use the personal information you provide with your application for purposes of considering you for a position at Sperry Marine, and if you are offered a job or become employed by Sperry Marine, for employment-related purposes. The legal basis of applicant data processing is deemed necessary for the performance of a contract with the data subject or to take steps to enter into a contract.

By applying for a position, you agree that we may use your personal information for recruitment and if you are hired, employment-related purposes. Your personal information will not be shared with others for non-recruitment or employment purposes except as consistent with our general website privacy policy. Failure to provide your personal information will prevent us from contacting you and evaluating your application for the job.
